ORDER CORRECTING ORDER APPROVING PGA TARIFF

Issue Date: November 21, 2022

Effective Date: December 4, 2022

On November 21, 2022, the Commission issued an order approving tariff sheets filed by The Empire District Gas Company d/b/a Liberty (Liberty EDG) to reflect changes in its Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas. That order will become effective on December 4, 2022.

The tariff filed by Liberty EDG correctly describes the new PGA rates, but the Commission's order inadvertently transposes a number in a chart describing the impact Liberty EDG's proposed PGA tariff will have on its PGA rates in its Northwest service area. The following chart corrects the entry for the new total PGA for the Northwest gas service area as follows.

Gas Service Area	Current Total PGA	New Total PGA	Difference
South	\$0.96720	\$1.154290	+0.18709
North	\$0.71850	\$1.054620	+\$0.33612
Northwest	\$0.64494	\$1.305140	+\$0.66020

The Commission finds it reasonable for this order to be effective in less than thirty days so that the corrective order will be effective at the same time as order to be corrected.

THE COMMISSION ORDERS THAT:

1. The Commission's Order Approving PGA Tariff issued on November 21, 2022, to be effective December 4, 2022, is corrected, as described in the body of this order.

2. This order shall become effective on December 4, 2022.
