**ORDER DIRECTING FILING**

On September 3, 2013, Laclede Gas Company, as directed by the Commission, filed a revised tariff sheet. The tariff sheet has an effective date of October 4, 2013. On September 5, Laclede filed a motion requesting that the Commission approve the tariff sheet to become effective on and after October 1, which is in less than 30 days. In its motion, Laclede states that its request resulted from discussions with the Staff of the Commission.

The Commission is allowed to approve tariffs on less than 30 days' notice for good cause.<sup>1</sup> It is not clear, from the motion, what "good cause" exists to approve the tariff to become effective on October 1, rather than October 4. It is apparent from the motion, however, that Laclede's request resulted from Staff's input. The Commission will therefore direct Staff to file a recommendation stating whether there is good cause for approving the tariff sheet on less than 30 days' notice and what constitutes such good cause.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file, no later than September 25, 2013, a recommendation stating whether there is good cause for the Commission to approve the revised tariff sheet on less than 30 days' notice and if so, what constitutes such good cause.
2. This order shall become effective upon issuance.
