**REQUEST FOR EXTENSION OF TIME
TO SUBMIT STATEMENTS OF POSITION**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") on behalf of itself, the Staff of the Missouri Public Service Commission ("Staff"), the Office of the Public Counsel ("OPC"), Consumers Council of Missouri ("CCM"), Kansas City Power & Light Company ("KCPL"), Midwest Energy Consumers Group ("MECG"), Missouri Division of Energy ("DE"), National Housing Trust ("NHT"), Natural Resources Defense Council ("NRDC"), Renew Missouri Advocates d/b/a Renew Missouri ("Renew Missouri"), Spire Missouri, Inc. ("Spire"), and Tower Grove Neighborhood Community Development Corporation ("Tower Grove"), known collectively herein as "the Parties," and hereby submits this *Request for Extension of Time to Submit Statements of Position* ("Request").

1. On August 1, 2018, the Missouri Public Service Commission ("Commission") issued its *Order Amending Procedural Schedule*, which established the date for submission of Statements of Position in this matter as October 4, 2018.

2. In the meantime, Ameren Missouri has sought to engage the Parties in settlement discussions to determine if a satisfactory resolution to this proceeding can be reached. In furtherance of those ongoing discussions, Ameren Missouri consulted with the Parties regarding the delay of the submission of Statements of Position until October 10, 2018. The Parties noted in the preamble above have agreed that a delay is appropriate.

WHEREFORE, Ameren Missouri prays on behalf of the Parties that the Commission will delay the deadline for the submission of Statements of Positions until October 10, 2018.
