Mr. Kartmann,

I am a property owner in StoneBridge Village. It is my understanding that Missouri American Water Corp is attempting to increase my water and sewer rates. I have also received conflicting information that Missouri American Water will be attempting to charge me for any needed service done to my grinder pump. I hope this is not true, therefore I am asking that you reply to this letter so that I can be accurately informed as to what is being done to my rates and why.

My water usage is extremely high in the summer months. As a resident of StoneBridge Village I am required to have an underground irrigation system. This system operates off the same meter as my house water requiring me to pay a commodity fee on my irrigation. If you would apply the numbers mentioned by your organization to my use, you will see that the increase is devastating. I am sure that the sizeable connect fees are set up to make up for the brunt of Roark's infrastructure losses. Why such a major increase for my property?

The sewer fee has me concerned as well. Where is the added operational cost coming from? It is my understanding that Roark Water abandoned the treatment plant and all my wastewater is being pumped to Branson. Was there a bond associated with the plant that Missouri American Water is paying on? If not, I seem to be missing a major piece of the puzzle for my rate to nearly triple.

The minimum increase was understated on the comment card I received. Under the proposed rates there is no usage applied to the minimum. I urge you to review the comment card sent out by Missouri American and take appropriate action.

Water is a necessity and in my opinion is our most precious resource. I understand that I have only one option, which is to pay for my water. Before coming to a decision I strongly request that Missouri American Water and the Public Service Commission look at the financial impact this rate increase will have for everyone in StoneBridge Village.
