# ORDER DIRECTING STAFF TO FILE RECOMMENDATION AND ESTABLISHING TIME FOR ANY OTHER PARTY TO FILE A RECOMMENDATION

Issue Date: January 31, 2022 Effective Date: January 31, 2022

Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) initially filed a tariff on March 31, 2021, to increase its rates for natural gas service. The Commission rejected that tariff on January 19, 2022, following approval of two stipulations and agreements that resolved all issues regarding that rate increase. Ameren Missouri was given leave to file a tariff to implement the provisions of the approved stipulations and agreements. Ameren Missouri filed its compliance tariff on January 28, 2022, to be effective on February 28, 2022.

The Commission will direct its Staff to file a recommendation regarding that compliance tariff filing, and will establish a time for any other party to file a recommendation.

#### THE COMMISSION ORDERS THAT:

- Staff shall file its recommendation regarding the compliance tariff filed by Ameren Missouri no later than February 10, 2022.
- 2. Any other party that wishes to file a recommendation regarding the compliance tariff filed by Ameren Missouri shall do so no later than February 10, 2022.
  - 3. This order shall be effective when issued.
