**ORDER DIRECTING RESPONSE TO REQUEST FOR APPROVAL OF
TARIFF**

On September 16, 2021, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty (“Midstates-Liberty”) filed a tariff that will amend its Rider PGA to extend the Purchased Gas Adjustment (“PGA”) Actual Cost Adjustment (“ACA”) recovery period beyond twelve months. That tariff carries an effective date of October 22, 2021. The Commission will direct its Staff to file a recommendation regarding that tariff.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Midstates-Liberty’s tariff (Tariff No. JG-2022-0058) by October 8, 2021.
2. Any other party wishing to respond to Midstates-Liberty’s tariff shall do so by October 8, 2021.
3. This order shall be effective when issued.
