

MISSOURI SCHOOL BOARDS' ASSOCIATION'S
POSITION STATEMENT REGARDING PRELIMINARY ORDER

COMES NOW, Missouri School Boards' Association (hereafter "MSBA") by and through its Counsel, Hendren and Andrae, L.L.C., Richard S. Brownlee, III, and for its Position Statement Regarding Preliminary Order respectfully submits as follows:

A. MSBA believes the Preliminary Order Approving Stipulation and Agreement meets the statutory requirements of Section 393.310 RSMo.

B. MSBA believes the Preliminary Order Approving Stipulation and Agreement is supported by competent and substantial evidence contained in the record.

C. MSBA further believes the Preliminary Order Approving Stipulation and Agreement is issued pursuant to Section 393.310 RSMo. which creates a unique, three-year aggregation program for the schools in the state of Missouri to purchase and transport


natural gas. MSBA further believes the aggregation program contemplates a yearly adjustment to assess the aggregation and balancing fee as set forth in the statute which is all contained within the overall three-year program.

D. Section 393.310 RSMo. further states, inter alia: "6. The commission may adopt by order such other procedures not inconsistent with this section which the commission determines are reasonable or necessary to administer the experimental program." MSBA believes this specific statutory directive allows the commission to implement accounting and supervisory principals that are unique to the program and which may be separate and distinct from accounting treatment in other utility cases.

Wherefore, MSBA prays an order approving the Preliminary Order Approving Stipulation and Agreement.


