4	Service Commission, and I'll be presiding here this
5	evening. In a moment I have the list here of people
6	who signed up to testify. I'll go ahead and call your

8	I'll swear you in to tell the truth, the whole truth,
9	and nothing but the truth, and we'll take your

25	parties and then ask questions and get answers, so we

19	your testimony.
20	JUDGE WOODRUFF: All right. Thank you,
21	Commissioner. Before I call the first witness,
22	there's one more thing I need to do, and that's
23	determine which parties are here with attorneys.

Good evening, Mr. Dodd. 12 MR. DODD: Good evening. 13 JUDGE WOODRUFF: Can you please raise your 14 right hand. WILLIAM DODD, being sworn, testified as follows: 15 16 JUDGE WOODRUFF: Thank you. Could you tell 17 us your name, please. 18 MR. DODD: My name is William Dodd. 19 JUDGE WOODRUFF: All right. What would you like to tell us? 20 21 MR. DODD: Well, I agree that energy costs 22 are going up. And I'm -- I know you have to -- you 23 have to pay the piper, so to speak. But I think that 24 their estimate -- I question how they estimate because they're based -- they're trying -- they're trying to 25

Page 6 project what this cost is going to be in the future. 1 2 Well, in -- we're in a down economy now. And like -like was mentioned earlier, the demand for power is 3 4 down. When the demand goes up, is AmerenUE going to 5 tell its shareholders, well, we just can't pay you 6 money because we're paying more and we have to go 7 through this rate commission business to get more 8 money to operate? Now, how good or accurate is your 9 projection for future costs? Do you guys have a 10 crystal ball? JUDGE WOODRUFF: It'd be a lot easier if we 11 did. 12 13 MR. DODD: Yeah, I know it. That's what I 14 want to know. I want to know -- I know it's not a science, a lot of it is hard, I'm sure. But it's very 15 16 important to -- because you know, the economy fluctuates, it goes up and down. You've got to figure 17 some kind of happy medium. And well, personally, you 18 19 know, somebody mentioned this. That budget billing is 20 a good thing, I think, because it helps me on a fixed 21 income to project my expenses cause I pay the same and 22 then I can regulate my usage, so to speak, and cut back at certain times when I can cut back and come out 23 24 at the end of the year pretty close to where I want to be because of the mathematical formula to determine 25

1	the rate. What I want to know is how good is your
2	method of determining what you think the costs are
3	going to be? Because we have we have a wild card
4	in here, and I suspect that may have had some
5	influence on this Proposition C, and that's your
6	environmentalists, people that object to human beings
7	being around. You know, we got a lot of coal in this
8	area, and that's a good source of power. Now they've
9	found out you got coal shale, you can get oil out
10	there. But you have a big objection, and evidently
11	the environmentalists lobby has a lot of influence on
12	competitions when it comes to making laws. Just
13	that's all I want to know.
14	JUDGE WOODRUFF: Well, I can't actually
15	answer your question about whether we have the crystal
16	ball. But if you go out and talk to Lena Mantle over
17	here after the hearing, she's one of out staff persons
18	and as well as the company, they can give you more
19	answers about that. Commissioner Jarrett, do you have
20	any questions?
21	COMMISSIONER JARRETT: I don't have any
22	questions. I don't have any questions, sir. Thank
23	you for your testimony. I appreciate it.
24	JUDGE WOODRUFF: Thank you. The next name
25	on the list is Darren Reddick. Good evening.

20	you know, a lot of it comes down to being more
21	efficient. And there was something that I had also
22	looked at on your information sheet, you know, and it
23	stated right here, "In particular Ameren Missouri is
24	seeking to recover the costs of installing two
25	scrubbers at the company's Sioux Power Plant, at the

1	cost of approximately \$6 million." It says, "These
2	scrubbers will eliminate nearly 100 percent of sulfur
3	dioxide emissions from the plant, providing cleaner
4	air for the Midwest. Approximately 110 million of the
5	263 million request relates to the Sioux scrubber
6	project." Okay. My question is this. When in
7	business, people normally have to purchase their
8	their tools, if you will, before, you know, before
9	charging your customers, you know. You have to take
10	care of your end before you can you can go on with
11	it, but you don't go after the customer after the
12	fact. If you understand what I'm saying. You don't
13	spend the money and then you come back and say, well,
14	you owe that to me and we're going to get that one way
15	or the other, whether we have to lobby or we have to
16	do that one way or the other. That's wrong. And then
17	it mentioned 600 million and then you have 110 and
18	263. Well, you add that together and that's 373
19	million. Where's the rest of it going? And you know,
20	that's the question that that I have on that end of
21	it. And like I said, you know, there's a lot of
22	people in this area that are really hurting right now,
23	and you know, we're we're no different than anyone
24	else. But our bank accounts are shrinking just, you
25	know, just as others are, but at the same time, how

What would you like to tell us? 20 MR. EVANS: Well, you know, being -- being 21 here in Missouri, I've only been here about eight, 22 nine years. I moved here from Arizona. And you know, 23 24 I know it's a different state, different climate, and 25 a situation like that, there's two utility companies
