## **STATUS REPORT**

**Comes now** the Office of the Public Counsel ("Public Counsel") and for its Status Report in response to the Missouri Public Service Commission's April 28 *Order Directing Status Report* states:

1. On March 15, 2017, a Mrs. Moore contacted the Office of the Public Counsel concerning a letter the Commission sent to Rachel Hackman, the owner of Fawn Lake Water Corp.

2. During that call, Mrs. Moore reported to Public Counsel the address for Fawn Lake Water Corporation is 3019 Old Highway 94, South, Suite 100, St. Charles, MO. In its filing, Public Counsel was reporting the contents of a telephone call and, at that time, had no independent knowledge of whether or not this was the correct business address for Fawn Lake Water Corp. Review of Returned Mail in the docket showed numerous mailing addresses, including 3910 Old Hwy. 945, St. Charles MO.

3. Public Counsel has been unable to reach Mrs. Moore at either of the phone numbers Mrs. Moore left with Public Counsel, however, Public Counsel has reviewed its notes from the conversation and determined it correctly reported to the Commission Mrs. Moore's statement that the correct address is "3019 Old Hwy 94 South."

4. In an attempt to respond to the Commission, OPC made three phone calls to Ms. Hackman, but was unable to contact her. Commission Staff indicates it has, however, been able to contact Ms. Hackman.

5. To attempt to verify the correct address, Public Counsel searched the Missouri Secretary of state's website and found the address listed on that website for Fawn Lake Water Corp. to be **3910 Old Highway 94 South, Suite 100**, Saint Charles, MO 63304.

6. Public Counsel has no comment on the use of a special process server.

WHEREFORE Public Counsel requests the Commission accept this pleading as documentation of the address it found on the Secretary of State's website, which it believes to be a correct address.
