On December 14, 2022, the Staff of the Commission (Staff) filed its recommendation regarding the 2020-2021 Actual Cost Adjustment (ACA) filing made by Summit Natural Gas of Missouri, Inc. (Summit) on November 4, 2021. Subsequently, Summit and Staff have held discussions and shared documents regarding Staff's recommendation.

Staff filed a status report on May 15, 2023, in which it stated that discussions and meetings among the parties continue and suggested a June 14, 2023, deadline to file either a settlement agreement or a joint proposed procedural schedule.

The Commission will follow Staff's suggestion.

## THE COMMISSION ORDERS THAT:

1. No later than June 14, 2023, Staff shall file either a settlement agreement regarding adjustments to Summit's ACA or a joint proposed procedural schedule.
