On December 14, 2022, the Staff of the Commission (Staff) filed its recommendation regarding the 2020-2021 Actual Cost Adjustment (ACA) filing made by Summit Natural Gas of Missouri, Inc. (Summit) on November 4, 2021. Subsequently, Summit and Staff have held discussions and shared documents regarding Staff's recommendation.

Staff filed a status report on April 6, 2023, in which it stated that discussions and sharing of documents continue and suggested a May 15, 2023, deadline to file either an additional status report or a joint proposed procedural schedule.

The Commission will follow Staff's suggestion.

THE COMMISSION ORDERS THAT:

1. No later than May 15, 2023, Staff shall file either a status report as to the progress of discussions regarding Staff's proposed adjustments to Summit's ACA or a joint proposed procedural schedule.
2. This order shall be effective when issued.
