ORDER DIRECTING FILING OF INFORMATION REQUIRED BY SECTION 393.275.1, RSMO

Issue Date: January 4, 2023 Effective Date: January 4, 2023

Section 393.275.1 RSMo, requires the Commission to notify the governing body of each city or county imposing a business license tax of approved utility rate increases exceeding seven percent. The rate increase approved in this case may exceed the seven percent threshold. To assist in the preparation of the required notice, Commission Rule 20 CSR 4240-10.060 requires the affected utility to provide the Commission a list of all cities and counties within its certificate area that impose a business license tax on the corporation's gross receipts, together with the name, mailing address, and title (that is collector, treasurer, clerk) of the official responsible for administration of the gross receipts tax in each of the listed cities and counties. The Commission will direct Spire Missouri to file the information required by the statute or inform the Commission if the approved rate increase does not exceed seven percent.

THE COMMISSION ORDERS THAT:

Spire Missouri shall file the information required by Section 393.275.1
 RSMo and Commission Rule 20 CSR 4240.10.060 no later than January 17, 2023.
