ORDER TRANSFERRING APPLICATION TO EXISTING PGA FILE

On June 14, 2022, Summit Natural Gas of Missouri, Inc. (SNGMO) filed proposed tariff sheets, Tracking No. JG-2022-0277, to reflect changes in the company's Purchased Gas Adjustment (PGA) clause. Also on June 14, 2022, the Commission issued an order directing an expedited recommendation by the Staff of the Commission (Staff), as well as setting a deadline to receive other comments on the tariff sheets.

SNGMO has a currently open PGA filing, File No. GR-2022-0191. In general, a utility's PGA filings made throughout the year are generally filed under a single File No. in order to true-up the purchased gas via a single Actual Cost Adjustment (ACA). Thus, the Commission will transfer the application, the tariff sheets, and the order to SNGMO's existing PGA filing, File No. GR-2022-0191. The application date and the existing order directing a Staff recommendation and directing responses will remain in effect, and will be repeated in this order for convenience.

THE COMMISSION ORDERS THAT:

1. SNGMO's PGA filing made on June 14, 2022, shall be transferred from File No. GR-2022-0350 to File No. GR-2022-0191.

2. Tariff Tracking No. JG-2022-0277 shall remain unchanged in number, but shall be assigned to GR-2022-0191.

3. All responsive filings regarding SNGMO's PGA filing of June 14, 2022, shall be made in File No. GR-2022-0191.

4. The Commission's order in File No. GR-2022-0350, made on June 14, 2022, shall be transferred from File No. GR-2022-0350 to File No. GR-2022-0191. The Commission's ordered paragraphs from its June 14, 2022, order are repeated here for convenience.

a. No later than June 21, 2022, Staff shall file a recommendation with regard to Tracking No. JG-2022-0277.

b. Any other entity wanting to comment on the tariff sheets shall do so no later than June 21, 2022.

5. File No. GR-2022-0350 shall be closed.

6. This order shall be effective when issued.
