## ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On November 3, 2022, Summit Natural Gas of Missouri, Inc. filed tariff sheets to reflect changes in the company's Regular Purchased Gas Adjustment clause. The tariff sheets have an effective date of November 21, 2022.

In consideration of the effective date of the tariff sheets, the Commission will direct the Staff of the Commission (Staff) to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets.

### THE COMMISSION ORDERS THAT:

1. No later than November 15, 2022, Staff shall file a recommendation with regard to Tariff File No. JG-2023-0087.
2. Any other entity wanting to comment on the tariff sheets shall do so no later than November 15, 2022.
3. This order shall be effective when issued.
