On January 4, 2023, Spire Missouri, Inc. d/b/a Spire filed revised tariff sheets to reflect changes in its Purchased Gas Adjustment for its eastern Missouri and western Missouri operating divisions. The tariff sheets bear an effective date of January 19, 2023.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any responses to the tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation concerning the above-referenced tariff sheets no later than January 10, 2023.
2. Any other responses to Spire's tariff sheets or Staff's recommendation shall be filed no later than January 12, 2023.
3. This order shall be effective when issued.
