## ORDER APPROVING TARIFF

Issue Date: June 24, 2008 Effective Date: June 27, 2008

On June 17, 2008, Aquila, Inc., d/b/a Aquila Networks–L&P filed revised tariff sheets that would cancel its Fixed Bill Pilot Program. Aquila states that it is cancelling the program pursuant to the Commission's order in Case No. EO-2007-0395.

The tariff sheets carry an effective date of July 17, but Aquila filed a motion asking the Commission to expedite its approval of the tariff sheets to allow them to go into effect on June 27. Aquila states that it seeks expedited treatment to allow for a more effective transition if the Commission decides to approve a merger between Aquila and a subsidiary of Great Plains Energy, Inc., which is pending in Case No. EM-2007-0374. Further, Aquila states that neither Staff nor the Office of the Public Counsel object to the tariff sheets or the Motion for Expedited Treatment.

The Commission's Staff filed an expedited recommendation regarding the proposed tariff on June 19. Staff recommended that the Commission grant Aquila's request for expedited treatment and approve the tariff, with an effective date of June 27. Staff believes that good cause exists to make the tariff sheets effective on less than thirty days' notice, so that customers will less likely be confused about the availability of a fixed bill program that is no longer available.

The Commission gave notice of Aquila's revised tariff sheets, and allowed others potentially interested until June 20 to object. No party responded.

Based on the recommendation of its Staff, the Commission will approve the submitted tariff sheets and grant the Motion for Expedited Treatment.

## IT IS ORDERED THAT:

1. The following tariff sheets filed by Aquila, Inc., d/b/a Aquila Networks–L&P on June 18, 2008, and assigned Tariff No. JE-2008-0748, are approved to become effective on June 27, 2008:
