ORDER SUSPENDING TARIFF

On September 28,¹ Union Electric Company d/b/a Ameren Missouri ("Ameren") filed revised tariff sheets that would amend its net metering program. According to Ameren, the revised tariff sheets are required to be filed according to Commission rules that became effective on August 30. The tariff sheets carry an effective date of October 28.

On October 18, the Staff of the Commission recommended that the Commission reject the tariff. Staff claims that Ameren's proposed changes are contrary to the pertinent statute and the Commission's net metering rule.

The Commission will suspend the tariff, and will schedule a prehearing conference.
