ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND SETTING A TIME FOR RESPONSES

On August 26, 2021, the Commission directed its Staff (Staff) to file a pleading stating the date that Staff would be able to file a recommendation on Summit Natural Gas of Missouri Inc.'s (Summit) *Application for Approval of Tariff Revision to Extend Equipment Rebate Program Pilot and Request for Waiver*, and accompanying tariff sheets. Staff filed a pleading stating that it can file a recommendation by October 4, 2021. The Commission will direct Staff to file a recommendation by that date.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation on Summit's application and tariff sheets no later than October 4, 2021.
2. Any responses to Staff's recommendation or Summit's application and tariff sheets are due no later than October 14, 2021.
3. This order is effective when issued.
