## ORDER DIRECTING RESPONSE TO APPLICATION FOR APPROVAL OF TARIFF

On September 24, 2021, Spire Missouri, Inc. filed a tariff that will amend its Rider PGA to allow for a downward adjustment factor of \$0.30 per Therm. The change is intended to mitigate the rate impacts of Winter Storm Uri and current increased market conditions for customers. That tariff carries an effective date of October 24, 2021. The Commission will direct its Staff to file a recommendation regarding that tariff.

### THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Spire Missouri's tariff (Tariff No. JG-2022-0060) by October 8, 2021.
2. Any other party wishing to respond to Spire Missouri's tariff shall do so by October 8, 2021.
3. This order shall be effective when issued.
