On September 24, 2021, Spire Missouri, Inc. filed a tariff that will amend its Rider

PGA to allow for a downward adjustment factor of \$0.30 per Ccf. The change is intended

to mitigate the rate impacts of Winter Storm Uri and current increased market conditions

for customers. That tariff carries an effective date of October 24, 2021. The Commission

will direct its Staff to file a recommendation regarding that tariff.
