ORDER APPROVING TARIFF

Issue Date: October 20, 2021

Effective Date: October 30, 2021

On September 30, 2021, Summit Natural Gas of Missouri, Inc. (SNGMO) filed an application for approval of a tariff that will amend its Purchased Gas Adjustment Rider. SNGMO filed substitute tariff sheets on October 14, 2021. The amended tariff will allow SNGMO to seek Commission approval to mitigate some of the rate impacts of extraordinary events, such as the February 2021 cold weather event, by spreading the recovery of costs over a period exceeding 12 months. SNGMO's tariff carries an effective date of October 30, 2021.¹

The Commission ordered its Staff to file a recommendation by October 15, 2021, and allowed any other interested party to respond by that same time. Staff filed its recommendation on October 15. No other party responded.

Staff recommends the Commission approve the submitted tariff, or allow it to become effective on October 30, as requested. The Commission will approve the tariff. Because the tariff will be approved to be effective in less than thirty days from the date of this order, this order will be made effective in less than thirty days.

¹ SNGMO also asked the Commission to waive the 60-day notice requirements of Commission Rule 20 CSR 4240-4.017(1). SNGMO has shown good cause for the waiver of that requirement and it will be waived.

THE COMMISSION ORDERS THAT:

1. The tariff amendment submitted by SNGMO on September 30, 2021, and substituted on October 14, 2021 (Tariff No. JG-2022-0065) is approved to be effective on October 30, 2021. The tariff sheet approved is:

2. The 60-day notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
