**SOUTHWESTERN BELL TELEPHONE COMPANY,  
D/B/A AT&T MISSOURI'S ERRATA FILING**

COMES NOW AT&T Missouri<sup>1</sup> pursuant to Section 67.2679.7 RSMo (Cum. Supp. 2007), and files this errata to its Application for Video Service Authorization to the Missouri Public Service Commission ("Commission"):

1.     AT&T Missouri inadvertently did not make clear in its Application for Video Service Authorization, filed October 16, 2007, that each of the political subdivisions set forth in said Application were served with a letter sent on October 16, 2007, which stated in substance:

Pursuant to Section 67.2679.5 RSMo 2000 Cum. Supp. 2007, Southwestern Bell Telephone Company d/b/a AT&T Missouri (AT&T Missouri) hereby notifies you that AT&T Missouri filed today a video service application with the Missouri Public Service Commission (PSC) that includes your political subdivision. The PSC has 30 days to approve this application. If and when AT&T Missouri plans to launch video service in your political subdivision, AT&T Missouri will notify you 10 days or more in advance of the launch date as required under Section 67.2687 RSMo 2000 Cum. Supp. 2007.

2.     AT&T Missouri corrects its Application for Video Service Authorization through this errata, as verified by Tim Judge, the AT&T Missouri employee who directed the mailing of notices to each relevant political subdivision. Mr. Judge's affidavit is appended hereto as an Attachment.




