ORDER APPROVING TARIFF

Issue Date: May 21, 2009 Effective Date: May 22, 2009

Union Electric Company, d/b/a AmerenUE, has filed a tariff designed to implement a new Residential Lighting and Appliance Program. That tariff is set to become effective on May 22, 2009. AmerenUE's proposed program is intended to reduce energy consumption in residential lighting and appliance products by encouraging selection of ENERGY STAR products through a market transformation strategy. On May 12, Staff filed a recommendation indicating some concerns about the program, but recommending the Commission approve AmerenUE's tariff to implement the program if the company agrees to certain conditions. On May 15, AmerenUE indicated its acceptance of the conditions proposed by Staff.

Based on the recommendation of its Staff and the response filed by AmerenUE, the Commission will approve AmerenUE's tariff and will order AmerenUE to comply with the conditions recommended by Staff.

¹ The tariff filing originally carried an effective date of April 24, but AmerenUE voluntarily extended that effective date to May 22.

THE COMMISSION ORDERS THAT:

1. The tariff issued on March 25, 2009, by Union Electric Company, d/b/a AmerenUE, and assigned Tariff No. JE-2009-0691, is approved to be effective May 22, 2009. The tariff approved is:

- 2. Union Electric Company, d/b/a AmerenUE shall comply with the following conditions proposed by Staff:
 - a. In addition to annual reports and a final report, AmerenUE shall quarterly provide comprehensive quantitative reports for the program to Staff, Public Counsel, the Department of Natural Resources, and other interested stakeholders. The quarterly reports shall track the progress of implementation and evaluation of the program, beginning with the first quarter following implementation of the program;
 - b. Program EM&V (evaluation, measurement, and verification) and reporting shall be done separately for the St. Louis metro area, rural areas, and for the program in total;
 - c. At the end of the program term, AmerenUE shall share the program final report with all stakeholders and with all electric utilities (including cooperatives and municipals) in Missouri; and
 - d. Should AmerenUE decide to continue the program beyond its current

term ending September 30, 2011, AmerenUE shall invite all other electric utilities (including cooperatives, municipals, and investor-owned electric utilities) and other stakeholders in Missouri to meet and evaluate the opportunity for and interest in a statewide Residential ENERGY STAR Lighting and Appliance Program.

- 3. This order shall become effective on May 22, 2009.
- 4. This file shall be closed on May 23, 2009.
