ORDER APPROVING TARIFF

Issue Date: November 28, 2012 Effective Date: November 29, 2012

On October 29,¹ Union Electric Company d/b/a Ameren Missouri ("Ameren") filed revised tariff sheets that would amend its net metering program. According to Ameren, the revised tariff sheets are required to be filed according to Commission rules that became effective on August 30. The tariff sheets carry an effective date of November 28. However, Ameren extended the effective date to November 29.

The Commission's Staff filed a Recommendation of Non-Opposition to Tariff Filing Upon Commission Determination of Good Cause on November 15. Staff does not oppose the tariffs going into effect as it believes the tariffs carry out the purpose of the rule. However, Staff does not believe Ameren has stated good cause for the variances that Ameren requests via its tariff filing.

Good cause "generally means a substantial reason amounting in law to a legal excuse for failing to perform an act required by law." Similarly, "good cause" has also

been judicially defined as a "substantial reason or cause which would cause or justify the ordinary person to neglect one of his [legal] duties."³

Of course, not just *any* cause or excuse will do. To constitute *good* cause, the reason or legal excuse given "must be real not imaginary, substantial not trifling, and reasonable not whimsical." And some legitimate factual showing is required, not just the mere conclusion of a party or his attorney.

The Commission finds that Ameren's assertion of customer benefits and ease of administration for the company rise to the level of good cause. Based on the recommendation of its Staff, the Commission will approve the tariff sheets.

THE COMMISSION ORDERS THAT:
