STAFF RECOMMENDATION FOR APPROVAL OF TARIFF SHEETS

)

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Staff Recommendation for Approval of Tariff Sheets* states as follows:

1. On August 31, 2021, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty (MNG) ("Liberty) filed four tariff sheets to adjust its weather adjustment normalization rider ("WNAR") rates with a requested effective date of October 1, 2021. On September 1, 2021, the Commission directed Staff to file a recommendation on the pending tariff sheets no later than September 13, 2021. On September 10, 2021, Liberty filed a set of substitute tariff sheets, and noted that the substitute tariff sheets were revised to correct errors Staff had raised with Liberty regarding Liberty's original tariff sheets filing. On September 13, 2021, Staff filed a motion requesting the Commission grant Staff a one-day extension in order to review and prepare Staff's recommendation on Liberty's substitute tariff sheets filing. The Commission granted Staff's request and Staff's Recommendation is based on the substituted tariff sheets and the accuracy presumed therein.

2. Because the previous CSWNA (Current Semiannual Weather Normalization Adjustment) period experienced cooler weather than normal in Liberty's rate districts, the proposed rates are negative in the Northeast and West rate districts and less positive in Southeast rate district. This means a residential customer that used 100 Ccf of natural gas in a given billing month would see an approximate \$1.29

decrease in their bill from the currently effective WNAR rate if located in the Northeast or West rate districts. Likewise, a residential customer in the Southeast rate district using 100 Ccf of gas would see an approximate \$1.07 decrease in their bill from the currently effective WNAR rate.

3. As further explained in the attached memorandum, Staff has reviewed the tariff sheets as substituted by Liberty on September 10, 2021, with a requested effective date of October 1, 2021. Staff recommends approval of:

On August 31, 2021, Liberty Utilities (Midstates Natural Gas) Corp., d/b/a Liberty Utilities (MNG) ("Liberty Utilities" or "Liberty") filed four tariff sheets to adjust its weather normalization adjustment rider (WNAR) rates with a requested effective date of October 1, 2021. On September 1, 2021, the Commission directed Staff to file a recommendation on the pending tariff no later than September 13, 2021. On September 10, 2021 Liberty Utilities filed two substitute tariff sheets to address errors in the calculation of the reconciliation and weather.

Liberty's WNAR became effective on July 1, 2018. The purpose of the tariff is to adjust revenues for differences between actual heating degree days (AHDD) and normal heating degree days (NHDD). This is Liberty's seventh WNAR filing. Liberty's current and proposed rates are included in Table 1 below.

residential customer that uses 100 ccf in a given billing month would see an approximate \$1.29 decrease in their bill from the currently effective WNAR rate if located in the Northeast or West rate districts, and an approximate \$1.07 decrease in their bill from the currently effective WNAR rate if located in the Southeast district.
