## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

Issue Date: September 1, 2021

Effective Date: September 1, 2021

On August 31, 2021, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets in Tariff Tracking Number JG-2022-0044. Liberty projects that the changes to the WNAR tariff sheets will decrease the average monthly bill of the typical residential customer in its Northwest, West, and Southeast Districts by \$0.75, \$0.69, and \$0.47, respectively. The tariff sheets bear an October 1, 2021, effective date.

The Staff of the Missouri Public Service Commission (Staff) will be directed to file a recommendation. The Commission will establish a deadline for any other entity to file a response to the proposed tariff changes or to the Staff recommendation.

### THE COMMISSION ORDERS THAT:

1. No later than September 13, 2021, Staff shall file a recommendation regarding Tariff Tracking No. JG-2022-0044.
2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so before 4:00 p.m. September 14, 2021.

3. This order is effective when issued.
