ORDER SHORTENING TIME AND DIRECTING RESPONSES TO COMPLIANCE TARIFF FILING

On March 17, 2023,¹ Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed an application to change its Infrastructure System Replacement Surcharge (ISRS). On July 12, the Commission issued its *Order Rejecting Tariff and Authorizing ISRS Rates* (Order) rejecting the previously filed tariff sheet and authorizing the Company to submit a tariff sheet in compliance with the Order.

On July 13, Liberty filed a tariff sheet purported to be in compliance with the Order. The submitted tariff sheet carries a 30-day effective date of August 12, and is assigned Tracking No. YG-2024-0004.

The Commission will direct the Staff of the Commission (Staff) to file an expedited recommendation as to whether the tariff sheets comply with the Commission's Order. The Commission will also shorten the timeline for other responses.

THE COMMISSION ORDERS THAT:

1. On or before July 27, 2023, Staff shall file a recommendation as directed in the body of this order, or other appropriate filing.

2. Any other party wishing to file objections or a recommendation regarding Liberty's compliance tariff sheet filing shall do so on or before August 1, 2023.
