## NOTICE OF DECLASSIFICATION

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and for its Notice, states as follows:

- 1. The parties in this case, Staff, Public Counsel, and Missouri Gas Energy held a Settlement Conference on July 16, 2008, to determine whether any issues in this case could be settled.
- 2. As a result of this conference, Missouri Gas Energy agreed that certain materials filed by Staff could be declassified from Highly Confidential (HC) and made open to the public.
- 3. Staff had filed its Staff Recommendation on September 27, 2007 and its Rebuttal Testimony of Staff witness Paul Harrison on June 18, 2008 in both HC and NP versions.<sup>1</sup>
- 4. Upon further review and discussion of this information, MGE informed the parties that Staff's Recommendation and Mr. Harrison's Rebuttal testimony, with the *exception* of Schedule 2 of Staff's Rebuttal testimony, should no longer be classified HC.
- 5. Only Schedule 2 of Mr. Harrison's Rebuttal should remain classified HC. The Commission may treat as public the remainder of Mr. Harrison's Rebuttal and treat as public Staff's Memorandum contained in its Recommendation.

The portion of Staff's Memorandum that includes references to information from the ELA, and the portion including calculations from information provided on data request responses which were marked HC by the Company, are marked HC." The ELA (Environmental Liability Agreement) had been marked HC by the Company.
