On February 26, 2021, The Empire District Gas Company d/b/a Liberty (Empire Gas) filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Commission for an accounting authority order (AAO) and for modifications to its Purchased Gas Adjustment / Actual Cost Adjustment (PGA/ACA) tariff sheets. On August 2, 2021, Empire Gas filed notice that it would not be seeking an AAO and would instead deal with these matters in its general rate case.

The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close. More than 180 days have passed since Empire Gas filed its notice and by terms of the regulation, File No. GU-2021-0275 has closed.
