ORDER TO RE-PAGINATE TARIFF SHEETS

On June 27, 2013, Union Electric Company d/b/a Ameren Missouri filed a motion asking the Commission to authorize it to re-paginate certain tariff sheets within the company's Schedule No. 6. Ameren Missouri has recently restated its electric tariff to supersede and consolidate its previous tariff schedules 1 and 5. In the process of restating the tariff, certain superseded tariff sheets regarding the company's fuel adjustment clause were left out of the new schedule 6. Although those superseded tariff sheets are no longer in effect, they are still relevant to the Commission's Staff's prudence review for prior periods. For that reason, Ameren Missouri asks that the tariff sheets be re-paginated and included as part of the new tariff schedule 6. Staff supports that action.

The Commission finds Ameren Missouri's request to be reasonable and will order the tariff sheets to be re-paginated and included in the tariff schedule.


THE COMMISSION ORDERS THAT:

1. The following existing tariff sheets shall be re-paginated and included as part of Mo. P.S.C. Schedule No. 6:
 - a) Mo. P.S.C. Schedule No. 5, 1st Revised Sheet No. 98.8 to be re-paginated as Mo. P.S.C. Schedule No. 6, Original Sheet No. 70.1;
 - b) Mo. P.S.C. Schedule No. 5, 1st Revised Sheet No. 98.9 to be re-paginated as Mo. P.S.C. Schedule No. 6, Original Sheet No. 70.2;
 - c) Mo. P.S.C. Schedule No. 5, 1st Revised Sheet No. 98.10 to be re-paginated as Mo. P.S.C. Schedule No. 6, Original Sheet No. 70.3;

- d) Mo. P.S.C. Schedule No. 5, 1st Revised Sheet No. 98.11 to be re-paginated as Mo. P.S.C. Schedule No. 6, Original Sheet No. 70.4;
- e) Mo. P.S.C. Schedule No. 5, 1st Revised Sheet No. 98.12 to be re-paginated as Mo. P.S.C. Schedule No. 6, Original Sheet No. 70.5;
- f) Mo. P.S.C. Schedule No. 5, 1st Revised Sheet No. 98.13 to be re-paginated as Mo. P.S.C. Schedule No. 6, Original Sheet No. 70.6; and
- g) Mo. P.S.C. Schedule No. 5, 1st Revised Sheet No. 98.14 to be re-paginated as Mo. P.S.C. Schedule No. 6, Original Sheet No. 70.7.
