**ORDER APPROVING STIPULATION AND AGREEMENT**

Issue Date: October 30, 2013

Effective Date: November 9, 2013

On August 5, 2013, Kansas City Power & Light Company ("KCP&L") filed a *Request for Approval of Tariff and for Variance*. KCP&L specifically requested a variance from certain portions of the Commission's Electric Utility Renewable Energy Standard Requirements and the Commission's Net Metering Rules. The Commission issued an order effective September 4, 2013 suspending the tariff. On that same day, the Commission issued an order granting the applications to intervene for: Brightergy, LLC ("Brightergy"); the Missouri Department of Natural Resources, which since transferred to the Missouri Division of Energy ("MDOE"); and the Missouri Solar Energy Industries Association ("MOSEIA"). KCP&L filed an *Application for Clarification, Reconsideration and/or Rehearing*. A pre-hearing conference was held. On October 25, 2013, KCP&L, the Staff of the Commission, the Office of the Public Counsel, Brightergy, MDOE, and MOSEIA (collectively "Signatories") filed a joint *Stipulation and Agreement* for the Commission's approval.

The *Stipulation and Agreement* states the Signatories resolved their differences and that KCP&L will no longer seek approval of the tariff sheets filed with the Commission on August 5, 2013. Included as “Attachment A” of the *Stipulation and Agreement* are the terms of the revised tariff sheets that KCP&L will submit to the Commission once the tariff sheets for Tariff File No. JE-2014-0058 are withdrawn.

After reviewing the Stipulation and Agreement, the Commission finds it to be reasonable. The Commission determines it shall be approved.

**THE COMMISSION ORDERS THAT:**

1. The *Stipulation and Agreement* filed on October 25, 2013 is approved. A copy of the agreement is attached as Attachment 1 and is incorporated as part of this order.

2. Kansas City Power & Light Company; Staff of the Missouri Public Service Commission; Office of the Public Counsel; Brightergy, LLC; Missouri Division of Energy; and Missouri Solar Energy Industries Association are ordered to comply with the terms of the agreement.

3. No later than November 13, 2013, Kansas City Power & Light Company shall file with the Commission a notice of withdrawal of the Tariff File No. JE-2014-0058 and file new tariff sheets that reflect the tariff sheets attached to the *Stipulation and Agreement*.

4. Any outstanding motions or applications before the Commission are denied.

5. This order shall become effective on November 9, 2013.
