ORDER GRANTING ONE DAY EXTENSION FOR STAFF RECOMMENDATION AND RESPONSES

On August 31, 2021, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets in Tariff Tracking Number JG-2022-0044. The Staff of the Missouri Public Service Commission (Staff) was directed to file a recommendation, due September 13, 2021.

On September 10, 2021, Liberty filed substitute tariff sheets which addressed two concerns raised by Staff. On September 13, 2021, Staff requested a one day extension to file its recommendation due to the need to review the substitute tariff filings.

The Commission finds the request reasonable and will grant it. Due to the changed deadline, the Commission will, on its own motion, also extend the deadline to file responses to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. On or before September 14, 2021, Staff shall file a recommendation regarding Tariff Tracking No. JG-2022-0044.
2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so on or before September 16, 2021.

3. This order is effective when issued.
