ORDER APPROVING GAS DELIVERY CHARGE ADJUSTMENT TARIFF

Issue Date: September 29, 2021

Effective Date: November 1, 2021

At the conclusion of Union Electric Company d/b/a Ameren Missouri's last general rate case, File No. GR-2019-0077 ("rate case"), tariff sheets including a Gas Delivery Charge Adjustment ("DCA") Rider became effective. On September 1, 2021, Ameren Missouri filed tariff revisions (Tracking No. JG-2022-0046) designed to implement its DCA for the 2nd Accumulation Period beginning September 1, 2020 and ending August 31, 2021. The tariff sheet bears a November 1, 2021 effective date. The Commission issued notice of the filing, set a time for intervention requests and responses, and directed the Commission Staff to file a recommendation. No response or requests to intervene were received. Staff filed its recommendation to approve the tariff sheet on September 22, 2021.

Staff states that the rates included on the tariff revisions are charges of \$0.0085/Ccf for customers served on the Residential Rate Schedule, and \$0.0008/Ccf for customers served on the General Service Rate Schedule. Staff states that as a result of the adjustment, a residential customer using 100 Ccf of natural gas each month will

experience a decrease of \$0.73 in their monthly bill for service. Staff recommended the Commission approve the tariff sheet, JG-2022-0046.

The Commission has reviewed the unopposed tariff sheet and Staff's recommendations and finds them reasonable. The Commission approves the tariff sheet to become effective on November 1, 2021.

THE COMMISSION ORDERS THAT:

1. The tariff sheet filed on September 1, 2021, in Tracking No. JG-2022-0046, is approved effective November 1, 2021.
2. This order shall be effective November 1, 2021.
3. This file shall be closed on November 2, 2021.
