**ORDER DIRECTING RESPONSE TO APPLICATION
FOR APPROVAL OF TARIFF**

On September 30, 2021, Summit Natural Gas of Missouri, Inc. (Summit) filed a tariff that will amend its Purchased Gas Adjustment Clause to allow recovery of costs over a multi-year period. The change is intended to mitigate the rate impacts of Winter Storm Uri. That tariff carries an effective date of October 30, 2021. The Commission will direct its Staff to file a recommendation regarding that tariff.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Summit's tariff (Tariff No. JG-2022-0065) by October 15, 2021.
2. Any other party wishing to respond to Summit's tariff shall do so by October 15, 2021.
3. This order shall be effective when issued.
