On September 2, 2022, Ameren Missouri filed one tariff sheet in Tariff Tracking No. JG-2023-0049 to adjust its weather normalization adjustment rider (WNAR) rates with a request for the rates to go into effect on November 1, 2022. On September 7, 2022, Case No. GT-2023-0090 was opened, which includes this tariff filing. On September 8, 2022, the Commission directed Staff to file a recommendation on the pending tariff no later than October 12, 2022.

This is Ameren Missouri's first WNAR filing. Ameren Missouri's WNAR became effective on February 28, 2022 in Ameren Missouri's general rate case, Case No. GR-2021-0241. The purpose of the tariff is to adjust revenues for differences between actual heating degree days (AHDD) and normal heating degree days (NHDD). The WNAR replaces Ameren Missouri's prior mechanism, the Delivery Charge Adjustment Rider (DCA). Ameren Missouri's current and proposed rates are included in Table 1 below.

Table 1: Current and Proposed WNAR Rates and DCA Rate Change by Class.

To be clear, Ameren Missouri's request is only to change the WNAR rates in this case. A residential customer that uses a 100 Ccf in a given billing month will see an increase of \$2.42 due to this request. However, because the DCA rates are expiring on the same date, the net change on the customer's bill will only be \$1.57. General Service customers are not subject to the WNAR rate and the DCA rate is expiring.

Staff Recommendation

Staff has reviewed the following tariff sheet and recommends approval of the following tariff sheet to go into effect for service on and after November 1, 2022, the requested effective date:
