The Commission opened this file on June 6, 2018, at the request of Commission's Staff, to assist in the re-writing of Spire, Inc.'s Cost Allocation Manual. On July 10, Staff filed a motion asking the Commission to notify interested stakeholders of an initial workshop meeting to begin the process of re-writing Spire's Cost Allocation Manual. Staff filed an amended motion on July 19, changing the date for the proposed meeting. The workshop meeting will take place on Wednesday, September 5, 2018 at the Commission's Offices at the Governor Office Building, 200 Madison St., Jefferson City, Missouri 65102, Conference Room 470, beginning at 9:30 a.m., and ending at approximately 3:00 p.m. The meeting will be open to the public, except for any discussion of confidential information.

Staff asks that entities or persons planning to attend the workshop tell Staff counsel by August 10 what they think should be on the agenda for the initial workshop and whether they would be willing to make a presentation on a topic they think should be on the agenda.

1. The Commission's data center shall provide a copy of this notice to all parties to Spire's most recent general rate cases (GR-2017-0215 and GR-2017-0216), excluding the City of St. Joseph, which has asked to be removed from the service list for this case.
