ORDER DIRECTING SPIRE WEST TO RESPOND TO STAFF RECOMMENDATION AND SETTING TIME FOR OTHER RESPONSES

On August 27, 2021, The Staff of the Commission (Staff) filed its recommendation about Spire Missouri, Inc. d/b/a Spire West's actual cost adjustment (ACA) filing. Staff proposed no dollar adjustments but did make several recommendations. Staff has asked that the Commission order Spire West to respond to those recommendations within 30 days. The Commission will order Spire West to respond to Staff's ACA recommendation and memorandum.

THE COMMISSION ORDERS THAT:

1. No later than January 14, 2022, Spire West shall file a response to Staff's recommendation.
2. Any other responses to Staff's recommendation or Spire West's ACA filing shall be filed no later than January 14, 2022.
3. This order is effective when issued.
