ORDER DIRECTING RESPONSE TO STAFF RECOMMENDATION REGARDING ACTUAL COST ADJUSTMENT FILING

On December 14, 2022, the Staff of the Commission (Staff) filed its recommendation regarding the 2020-2021 Actual Cost Adjustment (ACA) filing made by Summit Natural Gas of Missouri, Inc. (Summit) on November 4, 2021. Staff proposes adjustments to the ending ACA balances as of August 31, 2021, as shown in the table in the "Recommendations" section of the Staff Recommendation Memorandum. Staff also requests the Commission order Summit to respond to its concerns, comments, and recommendations in the Billed Revenue and Actual Gas Costs, Reliability and Gas Supply Planning, and Hedging sections of the Memorandum.

The Commission will direct Summit to respond to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. No later than January 18, 2023, Summit shall respond to Staff's proposed adjustments to the ending ACA balances as of August 31, 2021, as shown in the table in the "Recommendations" section of the Staff Recommendation Memorandum, and to Staff's concerns, comments, and recommendations in the Billed Revenue and Actual Gas Costs, Reliability and Gas Supply Planning, and Hedging sections of the Memorandum.
