JOINTLY PROPOSED PROCEDURAL SCHEDULE

COME NOW Summit Natural Gas of Missouri, Inc. (“SNGMO”), and the Staff of the Missouri Public Service Commission (“Staff”), (collectively, “parties”), through counsel and submit this jointly proposed procedural schedule.

1. On November 17, 2021 the Commission ordered the parties to jointly file a proposed procedural schedule by December 1, 2021.

2. In accordance with the Commission’s order, the parties propose the following procedural schedule:

Initial Post-Hearing Briefs	August 9, 2022
Reply Briefs	August 19, 2022

3. The parties also request that on and after May 13, 2022, the Commission (a) shorten the response time for all data requests to 10 calendar days and to 5 business days to object or notify that more than 10 calendar days are needed to provide the

requested information and (b) on and after June 8, 2022, further shorten the response time for all data requests to 5 business days and to 2 business days to object or notify that more than 5 business days are needed to provide the requested information.

WHEREFORE, the undersigned parties respectfully jointly propose the above procedural schedule and request that the Commission impose the procedural requirements also set out above in its order that sets the procedural schedule for this case.
