ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING A TIME FOR ANY RESPONSES TO AMEREN MISSOURI'S APPLICATION AND TARIFF FILING

On September 28, 2021, Union Electric Company d/b/a Ameren Missouri filed an *Application to Extend the ACA Recovery Period Under the Company's Rider PGA for Good Cause Shown and to Approve Updated Rates Reflecting Such Extension, and Motion For Expedited Treatment* along with a tariff sheet to extend the Actual Cost Adjustment (ACA) recovery period for adjustments authorized by the Commission under Ameren Missouri's Purchased Gas Adjustment (PGA) clause. The authorized PGA adjustments were to include the impacts of the February 2021 cold weather event. The tariff sheet to extend the ACA recovery period bears an effective date of November 1, 2021, and adjusts rates to reflect Ameren Missouri's requested extension. Ameren Missouri believes that extending the recovery time for the 2021 cold weather event will benefit the company and mitigate the rate impact to its customers. Ameren Missouri requests expedited treatment of its application and tariff sheet because of a November 1, 2021, deadline for its annual Rider PGA rates reset.

In consideration of the request for expedited treatment and the effective date of the tariff sheets, the Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on an expedited schedule. The Commission will

also establish a deadline for any other entity to file a response to the application, motion and tariff filing.

THE COMMISSION ORDERS THAT:

1. No later than October 14, 2021, the Commission's Staff shall file a recommendation concerning Ameren Missouri's request to extend the ACA recovery period and corresponding tariff sheet filed by Ameren Missouri, Tariff No. YG-2022-0062.
2. Any other person or entity wishing to comment on Ameren Missouri's tariff filing, request to extend the ACA recovery period, and request for expedited treatment shall file a response no later than October 14, 2021.
3. This order is effective when issued.
