NOTICE THAT TARIFFS WILL BE ALLOWED TO GO INTO EFFECT

Issue Date: November 29, 2021

On November 15, 2021, Spire Missouri, Inc., d/b/a Spire (East) and Spire Missouri, Inc., d/b/a Spire (West) filed the above-reference tariffs to change their Purchased Gas Adjustment factors as a result of the cost of natural gas. Those tariffs bear an effective date of November 30, 2021.

Staff filed a recommendation on November 19, asking the Commission to approve the tariffs. No party has objected.

Tariff No. JG-2022-0152 and Tariff No. JG-2022-0153 will be allowed to go into effect by operation of law on November 30, 2021, to establish rates on an interim basis, subject to refund, through the Actual Cost Adjustment (ACA) process, for service on and after November 30, 2021.
