STAFF RECOMMENDATION REGARDING TARIFF SHEET

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and files its *Staff Recommendation Regarding Tariff Sheet* and states as follows:

1. On February 24, 2023, Spire Missouri, Inc. d/b/a Spire (“Spire Missouri”) filed a tariff sheet in Tariff Tracking No. YG-2023-0146, which as noted in Spire Missouri’s transmittal letter, Spire Missouri had developed with the parties. The tariff sheet has an effective date of March 26, 2023, but Spire Missouri filed a contemporaneous motion that requested the Commission permit the tariff sheet to go into effect on March 6, 2023.

2. Staff reviewed the tariff sheet filed in Tariff Tracking No. YG-2023-0164 and recommends the Commission approve it, and further Staff has no objection to the Commission granting Spire Missouri’s request that this tariff sheet go into effect for service on March 6, 2023:

WHEREFORE, Staff recommends the Commission issue an order approving the tariff sheet filed in this matter in Tariff Tracking No. YG-2023-0164 and granting Spire Missouri’s request to allow the tariff sheet to become effective on March 6, 2023.


