## ORDER APPROVING PGA TARIFF

Issue Date: January 13, 2023

Effective Date: January 19, 2023

On January 4, 2023, Spire Missouri, Inc. d/b/a Spire filed revised tariff sheets to reflect changes in its Purchased Gas Adjustment (PGA) for its eastern Missouri and western Missouri operating divisions. The tariff sheets bear an effective date of January 19, 2023.

Spire's proposed PGA tariff sheets will have the following effects on its PGA rates:

Operating Division	Current Total PGA per Ccf	New Total PGA per Ccf	Difference
East	\$.70904	\$.77588	+\$0.06684
West	\$.92304	\$1.07545	+\$0.15241

Staff filed a recommendation on January 10, 2023. In its recommendation, Staff explained that this file was established to track Spire's PGA factors to be reviewed in its 2022-2023 ACA filing. Staff recommends the proposed rate changes be approved on an interim basis, subject to refund, pending final Commission decisions in File Nos. GR-2023-0217, GR-2023-0157, GR-2022-0135, GR-2022-0136, GR-2021-0127, and GR-2021-0128. There is no change to the Actual Cost Adjustment factor with this filing. Staff recommends the tariff sheets become effective as requested on January 19, 2023. No other party filed a response.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. Based on the verified filings, the Commission finds that the proposed

tariff sheets conform to Spire's Commission-approved PGA clause. Given that Spire's PGA clause allows for PGA change filings to take effect after ten business days' notice, good cause has been shown pursuant to Section 393.140(11), RSMo 2016, to permit the tariff sheets to become effective on less than 30 days' notice.

The Commission concludes the proposed tariff sheets should be approved to become effective on January 19, 2023, on an interim basis, subject to refund, pending final Commission decision in this file and File Nos. GR-2023-0157, GR-2022-0135, GR-2022-0136, GR-2021-0127, and GR-2021-0128.

The Commission finds it reasonable for this order to be effective in less than 30 days so that the order will be effective on the same date as the tariff sheets.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets, assigned Tracking No. YG-2023-0122, are approved to be effective on January 19, 2023, on an interim basis and subject to refund, pending final Commission decisions in this file and in File Nos. GR-2023-0157, GR-2022-0135, GR-2022-0136, GR-2021-0127, and GR-2021-0128. The tariff sheets approved are:
