MO PSC Water Utility Small Company Rate Increase Procedure

## Dear Secretary:

Evergreen Lakes Water Company holds a certificate of public convenience and necessity granted by the Missouri Public Service Commission under which the Company provides water supply and distribution services in Franklin County, Missouri. The Commission first authorized the Company to provide regulated water utility service in June of 1970. The Company currently provides service to approximately 44 homes and 1 meter that services approximately 40 mobile homes within its certificated service area under the provisions of its Commission-approved tariffs. The Company's customer rates for water service were last changed in January of 1993.

Pursuant to 4 CSR 240-3,635 the Commission's rule pertaining to rate increase requests made by small water utilities, the Company is hereby requesting an increase of \$9,549.85 in its annual water system operating revenues. Based upon current customer rates and customer numbers, this increase represents a change of approximately 84% in the Company's annual water system operating revenues. The Company understands that the design of its customer rates, its service charges, its customer service practices, its general business practices and its general tariff provisions will also be reviewed during the Commission Staff's review of the rate increase request, and may thus be the subject of Staff recommendations at the conclusion of the rate increase process.

The specific reasons for the requested increase in the Company's annual operating revenues include: increases in operation and maintenance expenses; and to provide an adequate return on investment.

We must have an increase to tap on new users. We also need an increase to shut users off for non payment and then to turn them back on.

It is extremely important that we be able to charge a late fee. All other companies including utilities charge a late fee, if we are the only one that is not able to charge a late fee then we are the ones that don't get paid.

Today we are only able to charge \$75.00 for a tap on and I have attached a copy of the minimum cost for a tap on. This \$75.00 rate was set in 1970 and we have never had a raise. In 1993 I requested a raise and was told I was not allowed to ask for one at that time because we were getting a rate increase. My Dad was doing the work himself at that time and he owned his own backhoe so the cost was only for the parts for the tap on. He has passed away and we can not tap another user on until we get an increase. We recently tapped on 3 new users is there anyway we can recover some of the loss from those.
