**ORDER APPROVING COMPLIANCE TARIFF SHEETS**

Issue Date: February 23, 2022

Effective Date: February 28, 2022

On February 2, 2022, the Commission issued a report and order that resolved all remaining issues regarding Union Electric Company d/b/a Ameren Missouri's request to increase the company's annual revenues from its provision of electric service. In that report and order, the Commission formally rejected the tariff sheets Ameren Missouri originally filed on March 31, 2021, and authorized Ameren Missouri to file tariff sheets necessary to implement the provisions of the report and order and previously approved stipulations and agreements. Ameren Missouri filed its compliance tariff sheets on February 14, 2022, to be effective on March 16, 2022. Ameren Missouri asked the Commission to expedite its approval of the tariffs so that they can go into effect on February 28, 2022.

The Commission issued an order on February 17, 2022, directing its Staff to file a recommendation regarding Ameren Missouri's tariff sheets by February 22, 2022. That order also directed any other party wishing to file a recommendation regarding Ameren Missouri's tariff to do so no later than February 22, 2022.

On February 22, 2022, the Commission's Staff filed its recommendation regarding Ameren Missouri's compliance tariff. Staff concludes the tariff sheets comply with the

Commission's Report and Order and the approved stipulations and agreements, and recommends the Commission issue an order approving the compliance tariff sheets to be effective on February 28, as requested by Ameren Missouri. No other party filed a recommendation, and no party has filed a response to Staff's recommendation.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission concludes the submitted compliance tariff sheets are consistent with the Report and Order and the approved stipulations and agreements. The Commission finds good cause pursuant to Section 393.140(11), RSMo to expedite its approval of the tariffs so they can be effective on February 28, 2022, consistent with the provisions of the approved stipulations and agreements. The Commission also finds it reasonable to make this order effective in less than thirty days so that the effective date of the order will match the requested effective date of the tariff.

**THE COMMISSION ORDERS THAT:**

1. The proposed electric service tariff sheets submitted under Tariff No. YE-2022-0222 by Union Electric Company d/b/a Ameren Missouri are approved, as substituted, effective on and after February 28, 2022.
2. This order shall become effective on February 28, 2022.
