# ORDER DIRECTING FILING OF INFORMATION REQUIRED BY SECTION 393.275.1, RSMO

Issue Date: February 8, 2022 Effective Date: February 8, 2022

Section 393.275.1 RSMo, 2016 requires the Commission to notify the governing body of each city or county imposing a business license tax of approved utility rate increases exceeding seven percent. The rate increase approved in this case will exceed the seven percent threshold. To assist in the preparation of the required notice, Commission Rule 20 CSR 4240-10.060 requires the affected utility to provide the Commission a list of all cities and counties within its certificate area that impose a business license tax on the corporation's gross receipts, together with the name, mailing address and title of the official responsible (e.g. collector, treasurer or clerk) for administration of the gross receipts tax in each of the listed cities and counties. The Commission will direct Ameren Missouri to file the information required by the statute.

#### THE COMMISSION ORDERS THAT:

- Ameren Missouri shall file the information required by Section 393.275.1
  RSMo and Commission Rule 20 CSR 4240-10.060 no later than February 22, 2022.
