### ORDER GRANTING MOTION TO MODIFY PROCEDURAL SCHEDULE

Issue Date: November 22, 2021 Effective Date: November 22, 2021

These cases are set for hearing beginning on November 29, 2021, with the procedural schedule requiring the filing of statements of position on November 23, and a final reconciliation on November 24. On November 23, the Commission's Staff, acting on behalf of itself and the other parties, filed a motion asking the Commission to modify the remaining procedural schedule. The motion explains that the parties have reached an agreement in principle regarding many issues and ask that the first week of the scheduled hearing be canceled to allow more time to finalize the current settlement and to negotiate resolution of the remaining issues.

The motion requests that the existing procedural schedule be pushed back one week, with the hearing beginning on December 6. The post-hearing procedural schedule would not be changed. The Commission will grant that motion.

#### THE COMMISSION ORDERS THAT:

- 1. The Motion to Modify Procedural Schedule is granted.
- 2. The procedural schedule is modified to require the parties to file statements of position on November 30, 2021, with a final reconciliation to be filed December 1, 2021.

- 3. The evidentiary hearing will begin on December 6, 2021, and continue through December 10, 2021, beginning each day at 8:30 a.m.
  - 4. This order shall be effective when issued.
