## ORDER MODIFYING THE PROCEDURAL SCHEDULE

On January 11, 2022, The Empire District Electric Company d/b/a Liberty filed a motion to modify the procedural schedule. Liberty represents that this motion is filed with the consent of all parties. The motion requests that the Commission modify the procedural schedule to allow additional time for the filing of surrebuttal testimony. In support of its motion, Liberty asserts that it is waiting on responses to some data requests and that the requested modification does not impact any other dates on the procedural schedule. The Commission will grant the requested extension of time to file surrebuttal testimony.

### THE COMMISSION ORDERS THAT:

1. The procedural schedule is modified. Surrebuttal testimony shall be filed no later than January 20, 2022. The remaining procedural schedule is unchanged.
