ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: August 20, 2009

Effective Date: September 6, 2009

On July 8, 2009, the Commission issued its order expanding the certificate of convenience and necessity previously granted Missouri Gas Utility, Inc., in File No. GA-2009-0264, and directed MGU to file revised tariff sheets describing the new area and line certificates granted in this case. MGU filed three tariff sheets (Tariff File No. YG-2010-0075) on August 7, 2009, with an effective date of September 6, 2009.

Two of the sheets concern the instant application. MGU also filed a third sheet to correct an error it had made in the tariff filing in GA-2009-0264. MGU had denominated the revision number on Sheet No. 11 as First Revised, replacing Original, but should have marked it Second Revised, replacing First Revised. MGU stated that none of the remaining portion of Sheet No. 11 is in error, and requested to make this tariff correction along with its compliance tariff filing for this case.

The Commission's Staff filed its recommendation on August 19, 2009. Staff reviewed the tariff sheets, including corrected Sheet No. 11, and is of the opinion that the

sheets are in compliance with the Commission's order. Staff recommends approval of Tariff No. YG-2010-0075. No other party filed a response or recommendation.

Based on Staff's recommendation, the Commission determines that the tariff complies with the Commission's order. The Commission approves the tariff sheets to go into effect on September 6, 2009. In addition, the Commission approves the corrected tariff sheet No. 11.

THE COMMISSION ORDERS THAT:

1. Tariff No. YG-2010-0075, filed by Missouri Gas Utility, Inc., on August 7, 2009, is approved to become effective on September 6, 2009. the tariff sheets approved are:
