

On October 28, 2011, the Missouri Public Service Commission held a prehearing conference. Complainants, Linda T. Nelson and Vernon Ball, failed to attend. Under Commission rule 4 CSR 240-2.116 (3), a party may be dismissed from a case for failure to comply with a Commission order and failure to appear at a prehearing conference.

The Commission will direct Complainants to file a statement informing the Commission of why this matter should not be dismissed. Failure to respond to this order may result in dismissal of this complaint.

THE COMMISSION ORDERS THAT:

1. Complainants, Linda T. Nelson and Vernon Ball, shall file a statement, as described in the body of this order, no later than November 18, 2011.

2. This order shall become effective upon issuance.


